Greater Washington Partnership Elects Community Leaders from Across the Capital Region to its Board of Directors

Rosie Allen-Herring, President & CEO of the United Way of the National Capital Area; Lisa Hamilton, President & CEO of the Annie E. Casey Foundation in Baltimore, MD; and Greta J. The Partnership Board is charged with providing thought leadership and expert guidance, driving strategies that generate impact, and deepening relationships with the Capital Region communities the organization seeks to serve.

Moving the needle on social and economic change requires a cross-sector set of perspectives and expertise. Since its inception, the Partnership has maintained that prioritizing inclusivity and equity is essential for the Capital Region to compete and thrive. By adding three new board members from renowned community-based organizations, the Partnership is affirming its founding philosophy that big, institutional, complex problems need solutions that are cross-jurisdictional and that have the support and buy-in of the most influential and impactful organizations and voices across the region.

She is currently the President and Chief Executive Officer of United Way of the National Capital Area (United Way NCA) and is recognized as a thought leader who demonstrates the ability to convene public-private entities to leverage talent and resources and create collective impact in communities across the region and beyond. Formerly, Rosie was the Managing Director of the Community Investment and Engagement Division at Fannie Mae where she led corporate philanthropic strategy and oversaw the organization's social responsibility investments and employee-engagement efforts nationwide. Rosie has developed, implemented, and managed key business strategies for the Washington Metropolitan area, resulting in investments of more than \$2 billion in the region.

Lisa Hamilton is a visionary leader with a deep understanding of the needs of children, youth and families who has served as President and CEO of the Annie E. Casey Foundation since 2019. Previously, Hamilton was the Foundation's executive vice president and chief program officer, overseeing investments to promote community change, economic opportunity for families, and public system reform. She also guided efforts to strengthen the social sector and encourage the implementation of effective strategies through policy and data advocacy, leadership development, and research. Prior to joining the Foundation, Hamilton enjoyed a 14-year career at UPS. She held positions in corporate tax and public affairs before advancing to president of the UPS Foundation, where she directed global philanthropic and volunteer programs. She ultimately earned the post of vice president of corporate public relations, overseeing global media relations, reputation management and executive communications for the company.

For more than two decades, she has worked across the country exclusively in emerging markets and creatively financed and/or developed \$500 million of housing thereby helping unleash potential in modest income communities. Earlier in her career, Harris worked for the New York-based Local Initiatives Support Corporation (LISC) for nearly 17 years supporting economic development opportunities across the South and Mid-West regions. Known as a values-driven entrepreneur, she has transitioned traditional nonprofit organizations into mission-oriented businesses that promote sustainable corporate growth to yield greater community impacts. Harris was elected to the board of Markel Corporation in 2021 and appointed to the Virginia Tech University Board of Visitors in 2016. She serves on the boards of ChamberRVA, the Partnership for Housing Affordability, the Housing Partnership Network and the Richmond Jazz Society. She also co-chairs the Commonwealth of Virginia's bipartisan redistricting commission.

"At the Better Housing Coalition, we are passionate about changing lives and transforming communities through high-quality, affordable housing and equitable community building where there can be abundant opportunity access for all. I am eager to share my passion and expertise with the Greater Washington Partnership," said **Greta J. Harris, President & CEO of the Better Housing Coalition and incoming Director**.
